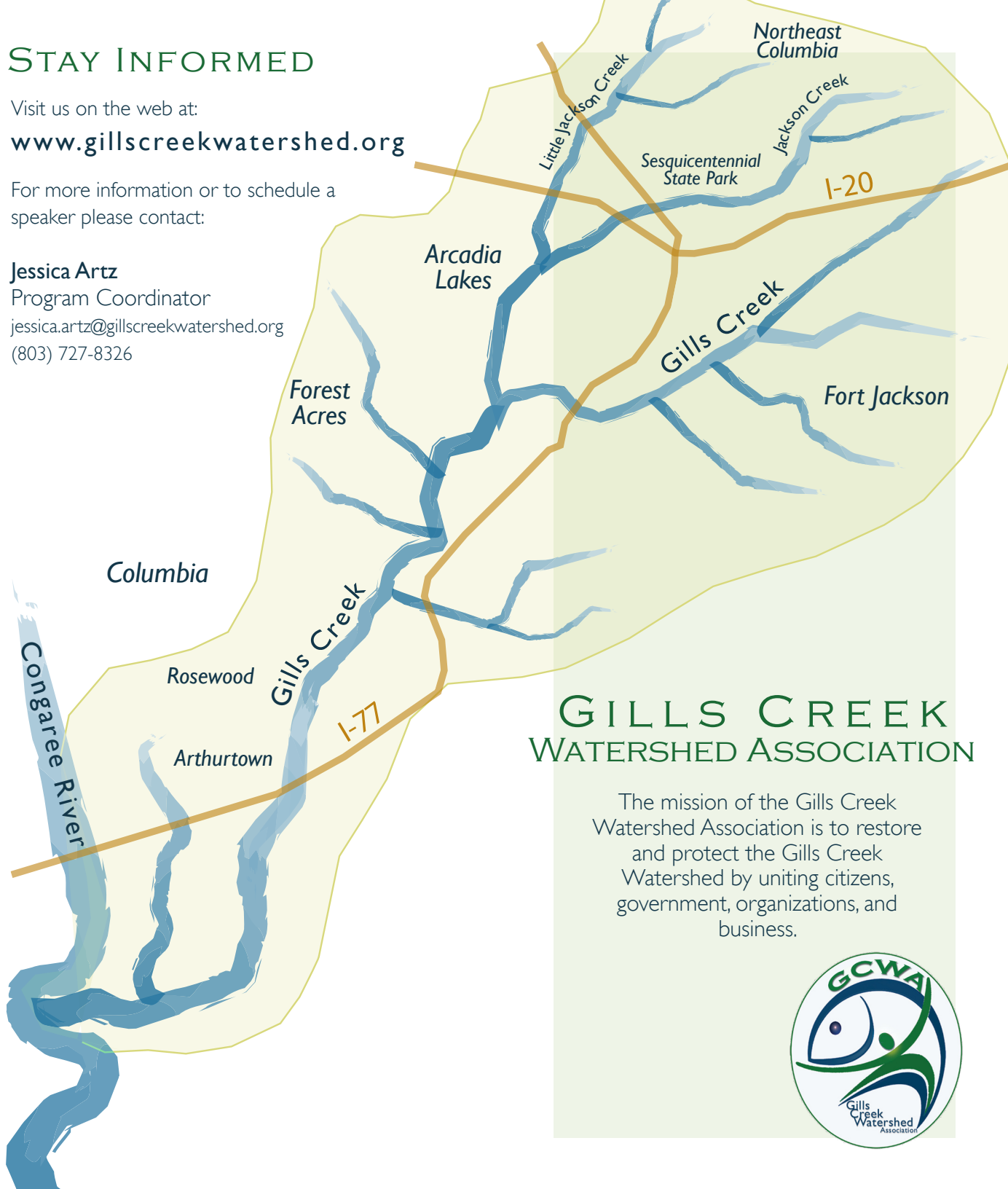

## A CALL TO ACTION

### To Improve and Protect Gills Creek Watershed

Richland County's Gills Creek Watershed is a wonderful and irreplaceable resource. Its lakes and creeks offer recreational opportunities, provide habitat for fish and wildlife, support agriculture, and provide drinking water for communities downstream. Unfortunately, our Watershed is in danger. Trash, sedimentation, and pollution have contaminated large areas within the Watershed. Restoration of the Watershed will require the united efforts of everyone—city, county, state, and federal entities, and most importantly—**you**—the citizens of Gills Creek!



### What is the Vision of the GCWA?

- Citizens in Gills Creek Watershed enjoy hiking/biking trails, kayaking and canoeing, and other activities on the water.
- Building codes are in place that promote conservation, green development and best management practices.
- New development proposals are assessed to determine impacts on water quality.
- Water quality is greatly improved and our creeks no longer impaired.
- Gills Creek Watershed is litter-free and erosion and lake sedimentation is greatly reduced.

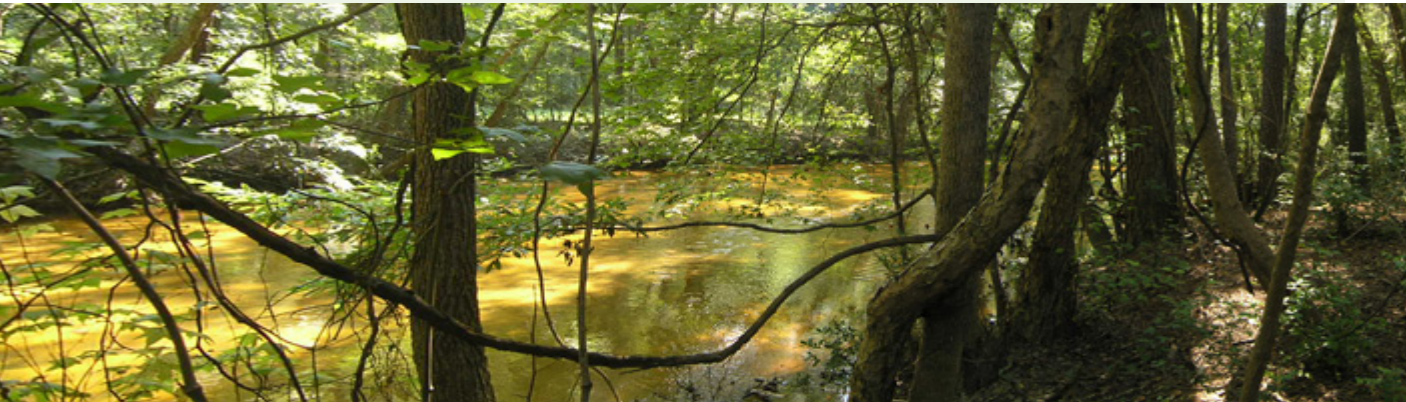
### Facts about the Gills Creek Watershed:

- It's one of South Carolina's most impaired watersheds.
- The three major headwaters flow through Spring Valley, Sesquicentennial State Park, and Fort Jackson.
- It contains over 70 miles of streams.
- It covers over 47,000 acres of land.
- The population is about 140,000.
- It includes parts of Richland County, Columbia, Cayce, Forest Acres, Fort Jackson, and Arcadia Lakes.

### What can YOU do to Protect the Gills Creek Watershed?

- Don't litter & pick up litter when you can.
- Pick up pet waste & dispose it of properly.
- Don't pour oil, paints, grease, or other materials into storm drains.
- Avoid placing yard debris near storm drains.
- Use proper amounts of fertilizer and pesticides.
- Become a member of the GCWA!

**What is a watershed?** A watershed is the area of land that catches rain and drains or seeps into streams, rivers, lakes, or groundwater. No matter where you live, you're in a watershed.



### What is Non-Point Source Pollution and how does it affect the Gills Creek Watershed?

During rain events, rainwater flows across surfaces like pavement, rooftops, and lawns. This rainwater picks up everything in its path, including oil, grease, fertilizer, herbicide, pet waste, sediment and trash. Many of these pollutants are found in the Gills Creek Watershed.

## ORGANIZATIONAL MEMBERSHIP
