Gills Creek Flood 2015 What To Do Now



Monday, October 12, 2015

Conditions in Gills Creek Watershed continue to improve. Spring Lake Dam and Beaver Dam are still stable and the lake levels are dropping. Gills Creek came up a couple of feet during Saturday's rain but no new flooding or dam failures were reported.

As we begin to pick up the pieces and move forward there are some important things to keep in mind. If you've experienced any type of a loss related to the storm you need to file a claim with FEMA at www.disasterassistance.gov or by calling 800-621-3362. You can find more information on filing a claim here. There are certain restrictions if you are repairing your home and you live in a floodplain. Contact the City or County in which you live before starting work if you live in a 100 year floodplain.

- The City has mandated that all irrigation systems that are hooked up to City water need to be shut off at the base. This will help conserve drinking water until the Columbia Canal is stabilized.
